**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SUNNYSIDE, WASHINGTON, APPROVING  
MAINTENANCE CONTRACT WITH ZOLL MEDICAL CORPORATION  
FOR PREVENTIVE MAINTENANCE**

**WHEREAS**, the City of Sunnyside has previously entered into an agreement with Zoll Medical Corporation for the purpose of preventive maintenance (the Agreement); and

**WHEREAS**, the current Agreement will expire March 31, 2013; and

**WHEREAS**, the City of Sunnyside and Zoll Medical have negotiated and agreed upon the terms of a new Agreement, to run from April 1, 2013 through March 31, 2014; and

**WHEREAS**, the City Council finds and determines that approval of such Agreement is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON**, as follows:


