A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, APPROVING AN ADDENDUM EXTENDING THE INTERLOCAL AGREEMENT WITH SUNNYSIDE SCHOOL DISTRICT NO. 201 FOR SCHOOL RESOURCE OFFICER PROGRAM

WHEREAS, the City of Sunnyside and School District entered into an Interlocal Cooperative Agreement for Services School Resource Officers with the School District August 22, 2011; and

WHEREAS, the City of Sunnyside and School District have negotiated an addendum of such Interlocal Agreement for the 2013-2014 school year; and

WHEREAS, the City Council of the City of Sunnyside and School District have found and determined that such School Resource Officer program is in the best interests of residents of the City of Sunnyside and School District, and will promote the general health, safety and welfare, and that such Addendum should be continued for the 2013-2014 school year.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

SECTION 1. That the Addendum to Interlocal Cooperative Agreement for Services School Resource Officers with Sunnyside School District No. 201, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby approved; and the Interim City Manager is hereby authorized to execute such Addendum for and on behalf of the City of Sunnyside.

SECTION 2. That this Resolution shall be effective upon passage and signatures hereon in accordance with law.

Addendum to the School Resource Officer Contract

THIS AGREEMENT HEREBY MODIFIES AND SUPERCEDES the contract entered into between the Sunnyside School District and City of Sunnyside.

The modifications are as follows:

This Agreement shall be extended for one (1) year beginning August 1, 2013 and shall terminate on July 31, 2014, upon the same terms and conditions provided in the Agreement. The consideration of One Hundred Twenty Five Thousand Dollars (\$125,000.00) payable by the School District to the City shall be made in twelve (12) equal payments, unless in response to budgeting considerations the School District finds it necessary or desires to prepay any/all of its obligations under the agreement.
