**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON, APPROVING
LETTER OF AGREEMENT BY AND
BETWEEN THE CITY OF SUNNYSIDE,
SUNNYSIDE SCHOOL DISTRICT NO. 201,
PORT OF SUNNYSIDE AND
SUNNYSIDE COMMUNITY HOSPITAL
(Sunnyside Connects)**

WHEREAS, the City of Sunnyside, Sunnyside School District No. 201, Port of Sunnyside and Sunnyside Community Hospital (the "Parties") previously entered into an Initial Agreement dated November 1, 2012 for the formation of Sunnyside Community Development Cooperative, now called Sunnyside Connects; and

WHEREAS, the coalition, Sunnyside United, has been formed and operating free of any direction from the Parties, and the purpose of the Initial Agreement has been substantially completed; and

WHEREAS, the Parties now desire to meet on an informal, but regular basis to discuss significant activities that each party is undertaking, particularly those activities that may affect other parties, and to discuss any matter of mutual concern; and

WHEREAS, the Parties have developed a Letter of Agreement setting forth the understanding of the parties with regard to such committee; and


WHEREAS, the City Council finds and determines that approval of such Letter of Agreement will promote mutual benefit of the parties and promote the general health, safety and welfare.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

Section 1. That the Letter of Agreement, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, by and between the City of Sunnyside, Sunnyside School District No. 201, Port of Sunnyside and Sunnyside Community Hospital is hereby approved; and the City Manager is hereby authorized to execute such agreement for and on behalf of the City of Sunnyside.

SECTION 2. This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.

Letter of Agreement

This Letter of Agreement (the "Agreement") dated **September, 26 2013**, by and between the City of Sunnyside, Sunnyside School District No. 201, Port of Sunnyside, and Sunnyside Community Hospital Association collectively (the "Parties").

Recitals

- A. The parties previously entered into that certain Letter of Agreement (the "Initial Agreement"), dated November 1, 2012 for the formation of the *Sunnyside Community Development Cooperative*, now called *Sunnyside Connects*. The intent of the parties was to formalize meetings between the parties to discuss community matters of mutual importance and specifically to form a community coalition as more fully set out in the Initial Agreement.
- B. The coalition, *Sunnyside United*, has been formed and is operating free of any direction from the parties, and other goals have been accomplished or are in progress.
- C. The purpose of the Initial Agreement has been substantially completed and the parties now desire to meet on an informal, but regular basis.

The Parties agree:

- 1. It is in the best interest of the community that the "CEO or their representative (and an elected official from each entity as an invited guest of the CEO) meet on an informal, but regular basis, to discuss significant activities that each party is undertaking, particularly those activities that may affect other parties, and to discuss any matter of mutual concern; and,
- 2. Each party commits to the others and to the community that it will direct its representatives to meet regularly, generally monthly, with representatives of the other parties; and,
- 3. The Initial Agreement shall be and is superseded in its entirety by this Letter of Agreement; and
- 4. This Letter of Agreement shall be effective for each party on the date it approves the Agreement.
