**A RESOLUTION OF THE CITY COUNCIL OF  
THE CITY OF SUNNYSIDE, WASHINGTON, AMENDING  
SIX-YEAR TRANSPORTATION IMPROVEMENT PROGRAM  
YEARS 2014 TO 2019**

**WHEREAS**, the City of Sunnyside has from year to year compiled and approved Six-Year Transportation Improvement Programs as required by state law; and,

**WHEREAS**, pursuant to Resolution No. 2013-62 approved August 12, 2013, the City Council has previously adopted a Six-Year Transportation Improvement Program for the years 2014 to 2019; and,

**WHEREAS**, the City has submitted application to the Transportation Alternatives Program (TAP) and was awarded a grant in the amount of \$157,300.00 to install 350' of curb & gutter, and 750' of new sidewalk along N. 16<sup>th</sup> Street; and

**WHEREAS**, the City Council finds and determines that such Transportation Improvement Program should be amended to incorporate this project and anticipated to commence in 2014-2015; and

**WHEREAS**, the City Council finds and determines that the Amended Six-Year Transportation Improvement Program for years 2014 to 2019 will promote the general health, safety and welfare of residents of the City of Sunnyside and is consistent with the city's Comprehensive Plan, and such improvement programs should be adopted and approved.

**IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON**, as follows:

**SECTION 1.** That the Six-Year Transportation Program for the years 2014 to 2019, as amended, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby approved.

**SECTION 2.** That a copy of this Resolution and Amended Six-Year Transportation Improvement Program, 2014 to 2019, be distributed to all appropriate agencies as required by law.

**SECTION 3.** This Resolution shall be in full force and effect upon passage, approval and signature thereon.
