**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SUNNYSIDE, WASHINGTON, AUTHORIZING  
THE SUBMITTAL OF A FEDERAL AVIATION ADMINISTRATION  
GRANT APPLICATION AND  
CITY MANAGER TO SIGN GRANT OFFER  
FOR THE DESIGN OF THE  
RUNWAY/TAXIWAY REHABILITATION PROJECT**

**WHEREAS**, the City of Sunnyside operates and maintains the Sunnyside Municipal Airport; and

**WHEREAS**, City staff has identified the need to rehabilitate the runway/taxiway areas and has been included on the Capital Improvement Program that is submitted to the Federal Aviation Administration (FAA) annually; and

**WHEREAS**, this project has been accepted and is now designated to receive funding from the FAA to start in FY2016; and

**WHEREAS**, City staff desires to submit a grant application to the FAA to fund the design and engineering of the Runway/Taxiway Rehabilitation Project in the amount of \$333,333.00; and

**WHEREAS**, City staff is recommending that City Council authorize the City Manager to sign the grant offer in early August and must be signed and submitted to FAA by August 21, 2015; and

**WHEREAS**, the City Council finds and determines that such approval is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.


**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:**

**SECTION 1.** That the City Council of the City of Sunnyside hereby authorizes the City Manager to sign and submit the Federal Aviation Administration grant application for and on behalf of the City of Sunnyside for funding the design and engineering of the Runway/ Taxiway Rehab Project.

**SECTION 2.** That the City Council of the City of Sunnyside hereby authorizes the City Manager to sign and submit the grant offer to the Federal Aviation Administration for and on behalf of the City of Sunnyside to fund the design and engineering of the Runway/ Taxiway Rehab Project; and the City Manager is hereby authorized take all actions reasonable and necessary to administer these funds with contractual authority.

**SECTION 3.** This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.
