**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON, AUTHORIZING
THE SUPPLEMENTAL AGREEMENT OF THE
16TH STREET IMPROVEMENT PROJECT WITH HLA**

WHEREAS, the City of Sunnyside is under contract with Huibregtse, Louman Associates to design the 16th Street Improvement Project; and

WHEREAS, the City of Sunnyside must adhere to Washington State Department of Transportation requirements and extend the contract because construction was delayed until 2016; and

WHEREAS, this agreement extends the completion date of design services for the project and will also change the City contribution of materials and labor from \$20,400 to \$25,900; and

WHEREAS, the City of Sunnyside City Council finds and determines that the supplemental consultant agreement with HLA is in the best interest of the residents of the City of Sunnyside and will promote the general health, safety and welfare;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WAHSINGTON, as follows:


SECTION 1. That the City of Sunnyside hereby authorizes the City Manager to sign the Supplemental Consultant Agreement with HLA as set forth in the agreement attached hereto as Exhibit "A", and the City Manager is hereby authorized to execute such agreement for and on behalf of the City of Sunnyside and to take all actions reasonable and necessary to administer performance of such agreement.

SECTION 2. This resolution shall be effective upon passage, approval and signatures hereon in accordance with law.
