**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON, AUTHORIZING
PROFESSIONAL SERVICES AGREEMENTS FOR TOURISM PROMOTION
SERVICES WITH SUNNYSIDE CHAMBER OF COMMERCE,
MISS SUNNYSIDE FLOAT COMMITTEE, AND THE PORT OF SUNNYSIDE**

WHEREAS, the City of Sunnyside published a request for proposals for the use of Lodging Tax Funds on September 3, 8 and 22, 2010; and

WHEREAS, the Lodging Tax Advisory Committee reviewed said proposals on November 2, 2010 and again on November 17, 2010 as required by RCW 67.28; and

WHEREAS, the City Council of the City of Sunnyside reviewed and approved five proposals recommended by the Lodging Tax Advisory Committee at a Special Meeting of the City Council on November 18, 2010 and authorized the requested appropriation be made to the 2011 budget; and


WHEREAS, the City Council finds and determines that acceptance of such proposals for reimbursement of certain costs of operation and maintenance of tourism-related services and advertising provided or secured is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.

THE CITY OF SUNNYSIDE, WASHINGTON, as follows:**

Section 2. This Resolution shall be effective upon passage and signatures hereon in accordance with law.
