**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON, APPROVING
AN ADDENDUM EXTENDING THE INTERLOCAL AGREEMENT WITH
SUNNYSIDE SCHOOL DISTRICT NO. 201
FOR SCHOOL RESOURCE OFFICER PROGRAM**

WHEREAS, the City of Sunnyside and School District entered into an Interlocal Cooperative Agreement for Services School Resource Officers with the School District for the 2009-2010 school year; and

WHEREAS, the City of Sunnyside and School District have negotiated a renewal of such Interlocal Agreement for the 2010-2011 school year; and

WHEREAS, the City Council of the City of Sunnyside and School District have found and determined that such School Resource Officer program is in the best interests of residents of the City of Sunnyside and School District, and will promote the general health, safety and welfare, and that such Interlocal Agreement should be continued for the 2010-2011 school year.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

SECTION 1. That the Addendum to Interlocal Cooperative Agreement for Services School Resource Officers with Sunnyside School District No. 201, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby approved; and the City Manager is hereby authorized to execute such Addendum for and on behalf of the City of Sunnyside.

SECTION 2. That this Resolution shall be effective upon passage and signatures hereon in accordance with law.



ADDENDUM

TO: INTERLOCAL COOPERATIVE AGREEMENT FOR SERVICES
SCHOOL RESOURCE OFFICERS

DATE OF AGREEMENT: OCTOBER 29, 2009

PARTIES: CITY OF SUNNYSIDE (City) and
SUNNYSIDE SCHOOL DISTRICT NO. 201 (School District)

The parties desire to amend and modify the above described Agreement to extend the terms and conditions of such Agreement as follows:

This Agreement shall be extended for one (1) year beginning August 1, 2010 and shall terminate on July 31, 2011, upon the same terms and conditions as provided in the Agreement. The consideration of One Hundred Thousand Dollars (\$100,000.00) payable by the School District to the City shall be made in twelve (12) equal payments, in an amount no less than Eight Thousand Three Hundred Thirty-three Dollars (\$8,333.00) per month, unless in response to budgeting considerations the School District finds it necessary or desires to prepay any/all of its obligations under this Agreement.

Except as amended and modified herein, the Agreement is ratified and confirmed in all respects.
