**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SUNNYSIDE, WASHINGTON, APPROVING THE PURCHASE  
OF AN ADA LIFT AT THE CENTRAL PARK SWIMMING POOL**

**WHEREAS**, the City of Sunnyside operates and maintains an outdoor public swimming pool at Central Park during the summer season; and

**WHEREAS**, the U.S. Department of Justice requires the City of Sunnyside to install a lift at its public swimming facilities to accommodate disabled persons as part of the Americans with Disabilities Act (ADA); and

**WHEREAS**, the City of Sunnyside solicited bids using the small works roster/ vendor list to determine the type of lift needed. This lift will replace a lift previously owned by the Parks and Recreation Department that is now inoperable, outdated and noncompliant; and

**WHEREAS**, W.M. Smith & Associates, Inc. has agreed to provide said lift as set forth in the quote attached hereto as Exhibit "A"; and

**WHEREAS**, the City Council finds and determines that the purchase of an ADA Lift at the Central Park Swimming Pool is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON**, as follows:

**SECTION 1.** That the Sunnyside City Council hereby approves the purchase of an ADA Lift at Central Park Swimming Pool as set forth in the quote attached hereto as Exhibit "A", and the City Manager is hereby authorized to execute such purchase for and on behalf of the City of Sunnyside and to take all actions reasonable and necessary to administer performance of such purchase.

**SECTION 2.** This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.
