

AMENDMENT NO. 1

INTERLOCAL AGREEMENT BETWEEN THE CITY OF SUNNYSIDE, WASHINGTON AND THE CITY OF WALLA WALLA, WASHINGTON, FOR THE HOUSING OF INMATES

THIS INTERLOCAL AGREEMENT AMENDMENT NO. 1 (Amendment) is made this 14th day of January, 2020 by and between the City of Sunnyside, Washington and the City of Walla Walla, Washington.;

WHEREAS, the City of Sunnyside and the City of Walla Walla entered into an Interlocal Agreement for the housing of City of Walla Walla inmates at the City of Sunnyside Jail on August 10, 2017;

WHEREAS, the City of Sunnyside and the City of Walla Walla wish to amend the Agreement by revising the duration of the Agreement as set forth in Section 2, the contact information as set forth in Section 4, and the compensation rates as set forth in Section 6 of the contract;

NOW THEREFORE, in consideration of the mutual covenants, condition and promises contained herein, the parties hereto mutually agree as follows:

SECTION 2. DURATION shall be amended as follows (removed terms are stricken and added terms are bolded and italicized):

2. DURATION

This Agreement shall enter into full force and effect from ***January 1, 2020*** ~~September 1, 2017~~ and end ***December 31, 2020*** ~~December 31, 2018~~, subject to earlier termination as provided by Section 3 herein. ~~This agreement~~ ***and*** shall be renewed automatically for like successive periods under such terms and conditions as the parties may determine. Nothing in this Agreement shall be construed to require CITY OF WALLA WALLA to house inmates in Sunnyside continuously.

SECTION 4. MAILING ADDRESSES shall be amended to reflect that the Secondary Contact person for the City of Walla Walla shall now be Kevin Braman, Police Captain.

SECTION 6(a). COMPENSATION shall be amended as follows (removed terms are stricken and added terms are bolded and italicized):

6. COMPENSATION

(a) Rates. Sunnyside agrees to accept and house CITY OF WALLA WALLA inmates for compensation per inmate at the following rates:

(i) For inmates staying less than 7 days, a rate of \$60.00 per day shall be assessed per inmate. This daily rate includes all transportation to and

from Walla Walla provided by Sunnyside. If the CITY OF WALLA WALLA provides transportation to and from Walla Walla within the 7 day period, the rate shall be assessed at ~~\$42.00~~ **\$50.00** per day.

(ii) For inmates staying longer than 7 days, a rate of ~~\$42.00~~ **\$50.00** per day shall be assessed per inmate. This daily rate includes all transportation to and from Walla Walla provided by Sunnyside.

(iii) These rates apply to minimum and medium classification inmates. The parties agree that Sunnyside will not charge a separate booking fee in addition to such rate. The date of booking into the Sunnyside Jail of CITY OF WALLA WALLA inmates shall be charged a minimum of a full daily rate per inmate regardless of the time of booking within a 24 hour period. The date of release from Sunnyside Corrections and/or returned to CITY OF WALLA WALLA, regardless of the time frame within a 24 hour day shall not constitute a charge by the City of Sunnyside against CITY OF WALLA WALLA.




