**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON, AUTHORIZING
THE TRANSFER OF FEDERAL AVIATION
ADMINISTRATION (FAA) ENTITLEMENTS TO
DEER PARK MUNICIPAL AIRPORT**

WHEREAS, the City of Sunnyside operates and maintains the Sunnyside Municipal Airport; and

WHEREAS, the City receives \$150,000 per year in entitlements from the Federal Aviation Administration (FAA) for capital improvements identified in our Airport Layout Plan, Master Plan, and Capital Improvement Plans. The City may only bank three (3) years of entitlements before the oldest entitlement rolls back to the FAA. The City is not using its FY2017 entitlements because our next projects are set for FY2021-22; and

WHEREAS, the FAA has requested the City consider transferring our FY2017 entitlement funds to the Deer Park Municipal Airport to assist them in completing their FY2020 capital improvements; and

WHEREAS, in FY2021, Deer Park will then transfer \$150,000 in entitlements back the City of Sunnyside; and

WHEREAS, the City Council finds and determines that such approval is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

SECTION 1. That the Sunnyside City Council hereby approves the agreement authorizing the FAA to transfer our FY2017 entitlements to Deer Park Municipal Airport in the amount of \$150,000, as set forth in and

attached hereto as Exhibit "A", and authorize City Council to execute such agreement for and on behalf of the City of Sunnyside and to take all actions reasonable and necessary to administer performance of such agreement.


SECTION 2. This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.
