

**RESOLUTION No. 2023-39**

**A RESOLUTION APPROVING ADDENDUM VI TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF ZILLAH AND THE CITY OF SUNNYSIDE FOR THE HOUSING OF INMATES.**

**WHEREAS,** The City of Zillah wishes to continue utilization of the detention facilities maintained by the City of Sunnyside and to compensate the City of Sunnyside for the care and custody of jail prisoners of Zillah arrested and/or detained for violation of the Zillah Municipal Code and adopted portions of the Revised Code of Washington; and,

**WHEREAS,** An Interlocal Agreement with Sunnyside was approved on July 5, 2017, outlining the terms of the agreement; and,

**WHEREAS,** Sunnyside notified Zillah that rates will increase for the year beginning January 1, 2024, through attached Addendum VI.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ZILLAH, WASHINGTON, DOES HEREBY APPROVE AS FOLLOWS:**

**Section 1. Approval of Addendum VI to Interlocal Agreement between City of Zillah and City of Sunnyside for Housing of Inmates:** The City Council for the City of Zillah approves the attached Addendum V to Interlocal Agreement between the City of Zillah and the City of Sunnyside for the housing of inmates, attached as Exhibit A and hereby authorizes the Mayor to sign it.

**Section 2. Effective Date:** The Resolution shall be effective from and after its passage and approval and giving notice requirement as required by law.



ADDENDUM VI

THIS ADDENDUM TO OUR INTERLOCAL AGREEMENT (hereinafter referred to as "Agreement") is made and entered into by and between the City of Sunnyside, Washington and the City of Zillah, Washington;

WHEREAS, the City of Sunnyside and the City of Zillah already have an Agreement for the housing of inmates;

WHEREAS, the City of Sunnyside desires to modify this Agreement;

NOW THEREFORE, in consideration of the mutual covenants, condition and promises contained herein, the parties hereto mutually agree as follows:

SECTION 6(a) COMPENSATION shall be repealed and replaced with:

(a) Rates. Sunnyside agrees to accept and house City of Zillah inmates for compensation per inmate at the rate of \$63.00 per day. The date of booking into the Sunnyside Jail of any City of Zillah inmate shall be charged a minimum of a full daily rate per inmate regardless of the time of booking within a 24 hour period. The date of release from the Sunnyside Jail and/or returned to City of Zillah, regardless of the time frame within a 24 hour day shall not constitute a charge by the City of Sunnyside against City of Zillah.

This Agreement shall be effective from January 1, 2024 or once fully endorsed by both parties, whichever is latter.

The remainder of the original Agreement remains unchanged.
