This Amendment is made by the Washington State Department of Corrections, hereinafter referred to as "Department," and the City of Sunnyside, hereinafter referred to as "City" or "Contractor," for the purpose of amending the above-referenced Contract, heretofore entered into between the Department and Contractor.

WHEREAS the purpose of this Amendment is to modify the period of performance and correct the per diem rates of compensation from the first amendment.

NOW THEREFORE, in consideration of the terms and conditions contained herein, or attached and incorporated and made a part hereof, the Department and Contractor agree as follows:

ARTICLE II, SECTION 2.1 TERM is hereby amended, in part, as follows:

Section 2.1 Term. This Agreement supersedes all previous oral and written contracts and agreements between the parties relating to the confinement, care, and treatment of Department offenders. This Contract commences on October 01, 2020 and continues through ~~((June 30, 2025))~~ June 30, 2024, unless terminated by either party pursuant to this Contract.

ARTICLE II, SECTION 2.4 PER DIEM BILLING is hereby amended, in part, as follows:

Section 2.4 Per Diem Billing. ~~((The per diem rate starting October 01, 2020 to June 30, 2022, is \$83.55 per Department offender. Beginning July 01, 2022 to June 30, 2023, the per diem rate is \$87.73 per Department offender. Beginning July 01, 2023 to June 30, 2024 the per diem rate is \$92.12 per Department offender. Beginning July 01, 2024 to June 30, 2025, the per diem rate is \$96.73 per Department offender.))~~ From January 01, 2019 through December 31, 2019, the per diem rate is \$50.64 per Department offender. From January 01, 2020 through December 31, 2020, the per diem rate is \$51.84 per Department offender. From January 01, 2021 through December 31, 2023, the per diem rate is \$54.44 per Department offender. Beginning January 01, 2024, through June 30, 2024 the per diem rate is \$57.16 per Department offender. [. . .]
