**A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE,
WASHINGTON, AUTHORIZING THE CITY MANAGER TO
AUTHORIZE SUBMISSION OF A FUNDING APPLICATION TO
THE TRANSPORTATION IMPROVEMENT BOARD – COMPLETE
STREETS PROGRAM**

WHEREAS, the Transportation Improvement Board (TIB) has an open call for agencies to submit funding applications for transportation improvements,

WHEREAS, eligible work under the TIB Urban Arterial Program includes reconstruction and major transportation infrastructure projects on federally functional classified routes which are consistent with the City's 6-Year Transportation Improvement Plan;

WHEREAS, a funding application was previously submitted for the 1st Street and Yakima Valley Highway Roundabout, and notice has been given this work is partially funded by the Surface Transportation Block Grant Program;

WHEREAS, TIB has encouraged the City to apply to the Urban Arterial Program for the balance of the improvements not previously funded;

WHEREAS, the City Council finds and determines that authorizing the City Manager to authorize submission of a funding application, is in the best interest of the residents of the City of Sunnyside and will promote the general health, safety and welfare;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

SECTION 1. That the City Council of the City of Sunnyside hereby authorizes the City Manager to submit a funding application for the

improvements, attached hereto as Exhibits "A", and act on behalf of the City of Sunnyside.

SECTION 2. This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.




