**WHEREAS**, the City Manager has identified Cus Arteaga of Arteaga Municipal Training and Services, LLC, as a suitable candidate to serve as the Interim Public Works Director, bringing many years of experience and qualifications to the role.

**NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON:**

**SECTION 1.** The City Council hereby authorizes the City Manager to enter into an agreement with Cus Arteaga of Arteaga Municipal Training and Services, LLC for the position of Interim Public Works Director attached hereto as Exhibit "A".
