

RESOLUTION 2025 - 31

A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE WASHINGTON, AUTHORIZING THE CONVERSION OF THE INTERSECTION AT S. 5TH STREET AND E. EDISON AVENUE AND S. 9TH STREET AND E. EDISON AVENUE FROM TWO-WAY STOPS TO FOUR-WAY STOPS.

WHEREAS, at the Council Study Session held on May 5, 2025, City Staff presented a recommendation to convert the intersections of S. 5th Street & E. Edison Avenue and S. 9th Street & E. Edison Avenue from two-way stops to four-way stops; and

WHEREAS, the recommendation is based on an evaluation of traffic and pedestrian safety concerns at these intersections, and it is the opinion of Staff that a four-way stop is the most financially economical solution to improving safety for both motorists and pedestrians; and

WHEREAS, the City Council finds it to be in the public interest to proceed with the conversion of the S. 5th Street & E. Edison Avenue intersection to a four-way stop in accordance with the proposed implementation schedule.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON:

SECTION 1. The City Council hereby approves the conversion of the intersection at S. 5th Street and E. Edison Avenue from a two-way stop to a four-way stop.

SECTION 2. The City Council further authorizes City Staff to implement the following process in connection with the conversion:

1. Conduct outreach to area businesses to inform them of the upcoming change and its safety benefits.
2. Advertise the upcoming stop sign conversion for a period of two weeks.

3. Flag the intersection with signage and visual cues for two weeks to bring awareness to the change.
4. Begin physical implementation of the four-way stop after the notification period.

SECTION 3. If this resolution is approved on May 12, 2025, and the process is followed as scheduled, the four-way stop at S. 5th Street & E. Edison Avenue shall be in place by June 9, 2025.

SECTION 4. The City Clerk is authorized to make the correction of scrivener's/clerical errors, references, Resolution numbering, section/subsection numbering and any references thereto.

SECTION 5. Effective Date. This Resolution shall be effective upon passage, approval and signatures heron in accordance with law.


