WHEREAS, the City Council of the City of Sunnyside wishes to acknowledge the dedication and contributions of EMS providers and commend their dedication to the safety and health of our community.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

SECTION 1. The City Council hereby approves a proclamation, attached hereto as Exhibit "A" proclaiming May 12 to May 18, 2025 as National Emergency Medical Services Week in the City of Sunnyside.

SECTION 2. The City of Sunnyside encourages citizens to support our local EMS providers.

SECTION 3. This resolution shall be effective upon passage, approval and signatures hereon in accordance with law.

WHEREAS, *it is appropriate to recognize the value and the accomplishments of emergency medical service providers be designation the Emergency Medical Services Week; and*


