**A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE,
WASHINGTON, AUTHORIZING A ONE-YEAR LEASE
AGREEMENT FOR A FLOCK CAMERA SECURITY TRAILER AND
APPROVING EXPENDITURE OF OPIOID SETTLEMENT FUNDS.**

WHEREAS, the City of Sunnyside is committed to enhancing public safety and reducing drug related crimes, including responding to ongoing crisis of opioid overdoses within the community; and

WHEREAS, the Police Department proposes leasing a mobile Flock Security Trailer to monitor problem areas and improve public safety; and

WHEREAS, the trailer will allow authorized department personnel to monitor locations remotely and be relocated as needed; and

WHEREAS, the City has received opioid settlement funds, and the proposed lease supports the intended use of those funds.

**NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF
THE CITY OF SUNNYSIDE, WASHINGTON:**

SECTION 1. The City Manager or designee is authorized to enter into a one-year lease agreement for a Flock Security Trailer attached hereto as "Exhibit A".

SECTION 2. The City Clerk is authorized to make the correction of scrivener's/clerical errors, references, Resolution numbering, section/subsection numbering and any references thereto.

SECTION 3. This Resolution shall be effective upon passage, approval and signatures heron in accordance with law.


