

RESOLUTION 2025 - 64

A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE, WASHINGTON, AUTHORIZING THE MAYOR TO AMEND AGREEMENT # A-2025-70 WITH INTERIM CITY MANAGER JIM BRIDGES EXTENDING THE TERM OF THE AGREEMENT UNTIL SEPTEMBER 30, 2025 OR ACTION RELATED TO THE PENDING INVESTIGATION.

WHEREAS, on June 9, 2025 the City Council entered into an agreement with Interim City Manager Jim Bridges through July 2, 2025, anticipating completion of the pending investigation involving the City Manager; and

WHEREAS, the investigation is on-going and requiring additional time; and

WHEREAS, the City Council now finds it necessary to extend the term of the agreement with Interim City Manager Jim Bridges until September 30, 2025, or a decision to take action regarding the pending investigation of the City Manager, whichever occurs first; and

WHEREAS, it is in the best interest of the city to amend the agreement to reflect this extension and continue the leadership of Interim City Manager Jim Bridges during this period.

NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON:

SECTION 1. The mayor is hereby authorized to amend Agreement # A-2025-70 with Interim City Manager Jim Bridges, extending the term of the agreement until September 30, 2025, or there is a decision to take action related to the pending investigation involving the City Manager, whichever occurs first, attached hereto as "Exhibit A".

SECTION 2. The City Clerk is authorized to make the correction of scrivener's/clerical errors, references, Resolution numbering, section/subsection numbering and any references thereto.

SECTION 3. This Resolution shall be effective upon passage, approval and signatures heron in accordance with law.

**AMENDMENT # 3 TO A-2025-70
INDEPENDENT CONTRACTOR AGREEMENT
BETWEEN
THE CITY OF SUNNYSIDE, WASHINGTON
AND
JAMES L. BRIDGES**

This amendment to Agreement # A-2025-70 ("Agreement") is made and entered into as of 25th day of August, 2025 by and between the City of Sunnyside, Washington ("City") and Jim L. Bridges ("Mr. Bridges").

WHEREAS, the City and Mr. Bridges entered into an Agreement # A-2025-70 on June 9, 2025, for Mr. Bridges to serve as Interim City Manager; and

WHEREAS, the City and Mr. Bridges entered into an amendment on June 30, 2025, for Mr. Bridges to serve as Interim City Manager until July 31, 2025, or the conclusion of the pending investigation; and

WHEREAS, the City and Mr. Bridges entered into an amendment on July 28, 2025, for Mr. Bridges to serve as Interim City Manager until August 31, 2025, or the conclusion of the pending investigation; and

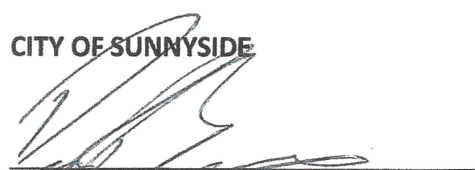
WHEREAS, the parties desire to extend the term of the Agreement for a limited period of time.

NOW, THEREFORE, the parties agree as follows:

1. Section 1 – Term: The term of the Agreement is hereby amended to extend the duration of Mr. Bridges' service as Interim City Manager until September 30, 2025, or the conclusion of the pending investigation of the City Manager, whichever occurs first.
2. Except as specifically amended herein, all other terms and conditions of Agreement # A-2025-70 shall remain in full force and effect.

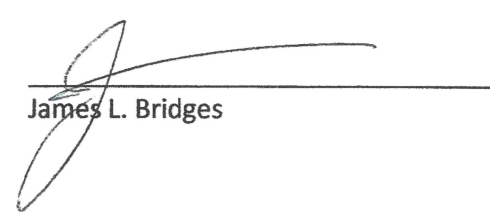

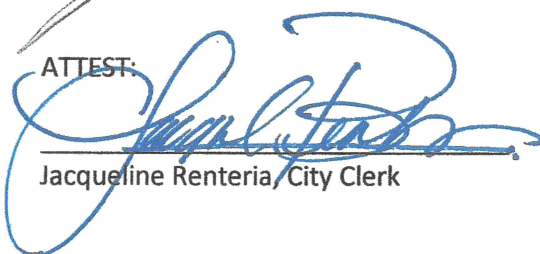
