

RESOLUTION 2025 - 91

**A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE, WASHINGTON, AUTHORIZING THE CITY OF SUNNYSIDE TO SPONSOR BRUNCH WITH SANTA AND THE SPIRIT OF SUNNYSIDE AWARDS DINNER AND AUCTION, INCLUDING THE PROVISION OF FACILITY USE, PURCHASE OF AWARDS, AND AUTHORIZATION FOR STAFF INSTALLATION AND REMOVAL OF EVENT EQUIPMENT.**

**WHEREAS**, the City of Sunnyside recognizes the importance of fostering community engagement and celebrating the exceptional contributions of its residents;  
and

**WHEREAS**, the Miss Sunnyside Committee Annually organizes Brunch with Santa, a family focused community tradition that offers families the opportunity to enjoy a festive holiday meal, participate in holiday themed activities and meet Santa Claus;  
and

**WHEREAS**, The Miss Sunnyside Committee also organizes the annual Spirit of Sunnyside Awards Dinner and Auction, a major fundraiser for the Miss Sunnyside Scholarship Program that also honors community members who demonstrate exceptional leadership, service and commitment to improving the City of Sunnyside;  
and

**WHEREAS**, the City of Sunnyside wishes to support the Miss Sunnyside Committee in the successful execution of these important events By providing use of the Sunnyside Community Center at no cost, allocating funds for the purchase of awards, and authorizing staff time for equipment installation and removal; and

**WHEREAS**, the City Council finds that sponsoring both brunch with Santa and the Spirit of Sunnyside Awards dinner and auction is in the best interest of the

community and reinforces civic pride, youth development and recognition of local leadership; and

**WHEREAS**, the City has prepared a cost analysis for the staff time and facility use associated with these events, as set forth in Exhibit A – Cost Breakdown and the total City contributions is not to exceed \$1,644 for both events;

**NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON:**

**SECTION 1.** The City of Sunnyside hereby authorizes sponsorship of Brunch with Santa on December 7, 2025, including the use of the Community Center at no charge and authorization of City staff to assist with installation set up and removal of event related equipment not to exceed \$348.00 as shown in Exhibit A.


**SECTION 2.** The City of Sunnyside hereby authorizes the sponsorship of the Spirit of Sunnyside Awards Dinner and Auction on April 25, 2026, including use of the Community Center at no charge, allocation of funds for the purchase of awards, and authorization of City staff to assist with installation, set up and removal of event related equipment not the exceed \$1,296.00 as shown in Exhibit A.

**SECTION 4. Effective Date.** This Resolution shall be effective upon passage, approval and signatures heron in accordance with law.
