



Hydrant Meter Rental Instructions

***Please allow a minimum of 48 hour notice for the Water Division to setup the hydrant meter.**

1. The meter assembly shall be used per instructions to measure all water used.
2. Water will be billed at the current City water usage rate. All water used and daily rental fees will be billed to the user upon return of the meter assembly. If use exceeds thirty (30) days, billing will be monthly. Deposit will be retained until all bills are paid in full.
3. Only City of Sunnyside personnel are authorized to make any adjustments, repairs or modifications to the meter assembly. If repairs to the meter are needed, please contact the Public Works Office.
4. If the assembly is lost, damaged or altered by the user, the user shall be responsible for any necessary repair or replacement costs which will be deducted from the deposit.
5. Only the assigned fire hydrant is to be used with hydrant meter. If the need to use a different hydrant than the one listed becomes necessary, please contact the Public Works Department for authorization.
6. It is the responsibility of the renter to return the meter to the Public Works/Community Development Department at City Hall located at 818 E. Edison Avenue, Sunnyside, WA 98944.
