- **Please provide enough candy for about 3,000 children. Individually wrapped candy; no homemade food items accepted.**
- **Participants passing out candy must wear masks and gloves. Social distancing measures in effect.**
- **Candy, agency literature, brochures and free items are welcome to reflect a family friendly environment. No vulgar or obscene decorations will be allowed. The SSPD reserves the right to refuse any materials or items deemed inappropriate for this event.**
- **Tear down and cleanup begins at 8 p.m. and must be completed by 9 p.m.**
