**VISITING DAYS AND HOURS:**

- ➔ Wednesdays 7pm-9pm (30 min sessions)
  - ➔ Sundays 8am-10am & 7pm-9pm
  - ➔ Special Visits - FEDERAL INMATES ONLY:  
Sundays 10am-11am (30 min sessions)
- These visits allow for one adult and up to 2 children 7 years of age or younger.

**RULES:**

- ➔ A Valid photo copy of Driver's License or State issued ID is required for all visitors over 18 years of age.
- ➔ A Valid State ID is required for all visitors above or appearing to be above 16 years of age.
- ➔ Students may be required to bring in a school ID before they are allowed in, they do not need an application.
- ➔ Visiting is first come first served. Visitors will not be signed in until the time of visiting, staying in line is required.
- ➔ Each inmate may have 1 visiting session per day. This includes children over the age of 8 years old.
- ➔ Children in high school must fill out visitor application.
- ➔ Disruptive visitors or parents of disruptive children will have their visits cancelled and asked to leave.
- ➔ If an inmate is not available for visits or has lost this privilege, it is their responsibility to notify their visitors before hand.\*\*\*
- ➔ Visitors are required to follow the posted dress code or they will be denied entry.
- ➔ If any of these requirements are not met or the Corrections Staff does not feel the attire is appropriate, the Sunnyside Police Department staff reserves the right to refuse admission to the facility for visits.
